RESOLUTION REQUESTING THE MUNICIPAL MAYOR, HON. MYRNA M. TORRES TO ISSUE AN EXECUTIVE ORDER URGING ALL MUNICIPAL EMPLOYEES TO UNDERTAKE MASSIVE TREE PLANTING ACTIVITIES ALONGSIDE THE SIBALOM AND BAGUINGIN RIVERS

WHEREAS, the Municipality is committed to the protection, preservation, and conservation of the environment;

WHEREAS, unabated deforestation done alongside of the watershed areas of Sibalom and Baguingin have caused the water to just cascade freely through the waterways;

WHEREAS, experienced of heavy flooding during rainy days expressed alarm over a disaster waiting to happen threatens the safety of the residents living nearby the Sibalom and Baguingin rivers;

WHEREAS, the launching of a massive tree planting activity is urgently needed so as to encourage residents living alongside the riverbanks;

WHEREAS, it is the responsibility of the Municipal Government to effectively implement rehabilitation of the watershed areas of Sibalom and Baguingin rivers;
