RESOLUTION CREATING BARANGAY BAROSONG HEALTH STATION AS THE HEALTH STATION OF BARANGAY ISIAN, BARANGAY CANABUAN AND BARANGAY BAROSONG

WHEREAS, Barangay Barosong and Barangay Canabuan are part of Cordova Health Station and Barangay Isian is part of Dapdap Health Station, thus separation of these three barangays from their mother Health Station is must;

WHEREAS, geographically, Barangay Barosong, Barangay Canabuan and Barangay Isian are traversed by Sibalom River and by a creek which separates these three barangays from Barangay Cordova and Barangay Sermon;

WHEREAS, during rainy season, the Sibalom River, which separates Barangay Barosong from Barangay Cordova and the creek, which separates Barangay Isian from Barangay Sermon, are often flooded thus crossing waterways is hazardous;

WHEREAS, most often when these waterways are flooded, constituents from these three barangays have to travel via the municipality of Leon just to reach their mother Health Stations, but most often, the constituents would prefer to have their medical check and their immunizations in the Municipality of Leon, which is more accessible to them;

WHEREAS, Barangay Barosong Health Station is currently undergoing construction and this construction is being funded by the development fund of these three barangays;

WHEREAS, when the construction of Barangay Barosong Health Station would be complete, this station will serve as the mother Health Station of Barangay Barosong, Barangay Isian and Barangay Canabuan;

NOW, THEREFORE, on motion of HON. ROEL T. JARINA, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Remedios Torrado, Hon. Jose Tavarro, Jr., Hon. Jose Donel Trasporto and Hon. Suzette Alquisada,

RESOLVED, to create Barangay Barosong Health Station As The Health Station Of Barangay Isian, Barangay Canabuan And Barangay Barosong,

RESOLVED FURTHER, to forward copies of this Resolution to the Municipal Mayor, Hon. Mryna M. Torres, to the Barangays Isian, Canabuan and Barosong and to all concerned for their information and/or appropriate action.
