Resolution No. 2004-100

RESOLUTION AUTHORIZING HON. AGATON TUMABOTABO, MUN. VICE MAYOR SIGNATORY ON CHECKS ISSUED BY THE MUNICIPALITY FOR PAYMENTS OF EXPENSES AND DISBURSEMENT OF FUNDS, IN BEHALF OF THE MUNICIPAL MAYOR, IN THE EVENT THAT THE VICE MAYOR IS IN ACTING CAPACITY AS MUNICIPAL MAYOR AND WHENEVER THERE IS TEMPORARY VACANCY IN THE OFFICE OF THE LOCAL CHIEF EXECUTIVE

WHEREAS, Section 46 of the Local Government Code (R.A. No. 7160) provides that "x x x when the x x x Municipal Mayor x x x is temporarily incapacitated to perform his duties for physical or legal reasons such as, but not limited to, leave of absence, travel abroad, and suspension from office, the x x x Municipal Vice Mayor x x x shall automatically exercise the powers and perform the duties and functions of the local chief executive concerned, except the power to appoint, suspend, or dismiss employee which can only be exercised if the period of temporary incapacity exceeds thirty (30) working days;

WHEREAS, Office Order No. 014 dated September 22, 2004 was issued by the Municipal Mayor designating HON. AGATON TUMABOTABO, Vice Mayor, as Acting Municipal Mayor, Local Government Unit of Tigbauan, Iloilo for the period September 27 to October 1, 2004;

WHEREAS, to ensure efficient, effective, economical and smooth transactions of the municipality, it is imperative that the Municipal Vice Mayor be authorized as signatory of checks issued by the municipality for payments of expenses and disbursement of funds, in behalf of the Municipal Mayor, in the event that the Municipal Vice Mayor is in acting capacity as Municipality Mayor and whenever there is temporary vacancy in the office of the local chief executive;

WHEREAS, such authority shall cease and terminate upon submission to the appropriate Sanggunian a written declaration by the local chief executive concerned that he/she has reported back to office as provided for in Section 46 (b) of the Local Government Code (R.A. No. 7160);

NOW, THEREFORE, on motion of Hon. Suzette T. Alquisada, Chairman, Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded by Hon. Alfonso Babiera, Hon. Orvillo Tangente, Hon. Jose Donel Trasporto and Hon. Romeo Ledesma,

RESOLVED, to authorize the Municipal Vice Mayor as signatory of checks issued by the municipality for payments of expenses and disbursement of funds, in behalf of the Municipal Mayor, in the event that the Municipal Vice Mayor is in acting capacity as Municipal Mayor and whenever there is temporary vacancy in the office of the Local Chief Executive;

RESOLVED FURTHER, to forward copies of this Resolution to the Municipal Mayor, Municipal Treasurer and the Managers of the depository banks of the LGU-Tigbauan, Iloilo, for their information and appropriate action.
