RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 09-04-152, LOT NO. 5142 OF DAISYLYN T. TAVARRO ET-AL OF BARANGAY 7(POBLACION) TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision No. SSA-09-04-152 and its supporting documents of Daisylyn T. Tavarro was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on September 13, 2004 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last September 14, 2004 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 5142, OTC/TCT No. F-32875 with three (3) lots has a total land area of 1,609 square meters more or less;

WHEREAS, the purpose of this application is to sell;

WHEREAS, the conditions of said approval shall be the following:

- a. In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;

- c. Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLRB;
- f. This applicant shall install drainage system on their property,

NOW, THEREFORE, on motion of HON. ORVILLO T. TANGENTE and duly seconded by Hon. Jose Donel Trasporto, Hon. Suzette Alquisada and Hon. Romeo Ledesma,
