WHEREAS, the late Vice Mayor HON. AMANDO TORRATO was married to Mrs. E Torrato, a retired DepEd classroom teacher, with whom he has four (4) children, one of whom (Febe) was once a Casual employee in this Local Government Unit (LGU);

WHEREAS, the late HON. AMANDO TORRATO was a dedicated public servant and employee, a loyal and trusted friend, a model husband, and a good father to his children;

WHEREAS, in extending this Resolution of Condolence to his family, it is our hope that it can assuage, event just a little, the pain And anguish of their irretrievable loss and irreparable bereavement;
