RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. 09-04-157, LOT NO. 946 OF ESTRELLA TRANCE ET AL OF BARANGAY 7(POBLACION) TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision No. SSA-09-04-157 and its supporting documents of Estrella Trance Et Al was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on October 6, 2004 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last October 6, 2004 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 1669, OTC/TCT No. O-16947 with four (4) lots has a total land area of 2,172 square meters more or less;

WHEREAS, the conditions of said approval shall be the following:

- c. Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLRB;
- f. This applicant shall install drainage system on their property,
