RESOLUTION FAVORABLY ENDORSING THE RENEWAL OF QUARRY APPLICATION OF MRS. AILEEN TAMON LOCATED AT BARANGAY NAPNAPAN NORTE, TIGBAUAN, ILOILO FOR COMMERCIAL SAND AND GRAVEL PERMIT AND TO THE OFFICE OF THE PROVINCIAL GOVERNOR, PENRO, DENR, REGION VI, AND THE BUREAU OF MINES AND GEOSCIENCES

WHEREAS, Sibalom River within the territorial jurisdiction of the Municipality of Tigbauan, Iloilo has been a good source for sand and gravel materials supplying both commercial and non-commercial infrastructure development in the City and Province of Iloilo;

WHEREAS, Article 100 of the Local Government Code of 1991 empowers the Local Sangguniang Bayan to pass and endorse application permits for commercial sand and gravel at the Sibalom River and for the efficient protection and management of its natural resources;
