Resolution No. 2004-116

RESOLUTION EARNESTLY APPEALING TO HON. JAMBY MADRIGAL, SENATOR OF THE REPUBLIC TO SET ASIDE AN AMOUNT FROM ANY OF YOUR AVAILABLE FUNDS FOR THE RECONSTRUCTION, IMPROVEMENT, AND SPRUCING UP OF THE MONUMENT MARKING THE FIRST GUERILLA AMBUSH IN SOUTHERN PANAY AGAINST A SUPERIOR JAPANESE FORCE AT BARANGAY NAMOCON, MUNICIPALITY OF TIGBUAN, PROVINCE OF ILOILO- - SEPTEMBER 2, 1942

WHEREAS, on September 2, 1942, (AM), eleven (11) truckloads of Japanese soldiers from Iloilo City, on their way to reinforce the Japanese occupation forces in Antique Province, were ambushed by a local contingent of newly-organized guerillas composed mostly of young native Tigbaueños;

WHEREAS, outnumbered and outgunned the group of guerillas retreated, leaving behind two (2) casualties – Pvt. Pedro Tronco and Pvt. Hugo Tupan, after which two civilians were immediately “butchered” by the Japanese soldiers in retaliation for the ambush;

WHEREAS, this heroism and gallantry in action by the Ilonggos at Barangay Namocon, Tigbauan, Iloilo, is a recorded historical fact as “. . . the first guerilla ambush in Southern Panay” against the Japanese invaders in world War II;

WHEREAS, as Monument depicting the gallantry of Ilonggos, was erected on the site of the ambush at Barangay Namocon some years ago, through the efforts of veterans during the incumbency of the late former Mayor Eugenio T. Torrento (himself a guerilla veteran of the 2nd World War),. And which is one of our historical landmarks and tourist attractions;

WHEREAS, this Monument was inappropriately constructed TOO NEAR the National road thus causing accidents to some pupils and some veterans who were side-swiped by vehicles some years ago while attending the annual program and wreath-laying ceremonies thereat every September 2nd;

WHEREAS, there is a move by both the officials of Barangay Namocon and Tigbauan Municipal Officials to move this Monument a short distance away from the National Road, but still within the ambush area, in order to avoid similar accidents in the future;

WHEREAS, it appears in COMELEC records that on May 10, 2004, we in Tigbauan gave you a total of 11,689 votes, which assured for you a comfortable margin as No. 4 winning Senator in this Municipality;

WHEREAS, we are sure of your sense of patriotism and history, being the daughter of Col. Antonio Madrigal, Aide to President Sergio Osmeña Sr. who waded ashore together with Gen. MacArthur at Red Beach, Palo, Leyte, on October 20, 1944, that started the Liberation of the Philippines;

NOW, THEREFORE, UPON motion of HON. ROMEO T. LEDESMA, Chairman, SB Committee on Tourism, History & cultural Affairs, and duly seconded unanimously, Be It

RESOLVED, as we do hereby resolved, to Earnestly Appeal to HON. JAMBY MADRIGAL, Senator of the Republic, To Set Aside An Amount From Any Of Your Available Funds For The Reconstruction, Improvement And Sprucing Up Of The Monument Marking The First Guerilla Ambush In Southern Panay Against A Superior Japanese Force At Barangay Namocon, Municipality Of Tigbauan, Province Of Iloilo – September 2, 1942,
