RESOLUTION REQUESTING THE HONORABLE MUNICIPAL MAYOR TO DESIGNATE SPECIFICALLY A BARANGAY DAY WHEREIN THE BARANGAY OFFICIALS CAN TRANACT WITH THE OFFICIALS OF THE MUNICIPALITY OF TIGBAUAN

WHEREAS, R.A., 7160 otherwise known as the Local Government Code of 1991 delegates specific functions and responsibilities to Local Government Units particularly on the effective and efficient delivery of basic services and facilities at the local level;

WHEREAS, the Municipality of Tigbauan, is composed of fifty two (52) barangays with a total population of 54,854 as of the last census;

WHEREAS, the officials of the different barangays are transacting business with the municipal officials for approval of their various requests for the implementation of projects in their respective barangays;

WHEREAS, to promote prompt and effective delivery of basic services to the inhabitants of the Municipality of Tigbauan in the respective barangays, it is imperative that a certain day in a week be designated as Barangay Day in order that Barangay Officials can transact business with the Municipal Officials of this Municipality;

WHEREAS, during the designated barangay day, municipal officials and heads of every department of this municipality are enjoined and required to be at their respective offices in order that necessary transactions of the barangay will be acted upon immediately and not to delay implementation of the projects of the barangays;

NOW, THEREFORE, on motion of Hon. Suzette T. Alquisada, Chairman of the Committee on Good Government, Public Ethics, Accountability and Civil Service, and duly seconded by Hon. Roel Jarina;

RESOLVED, to request the Honorable Municipal Mayor, Myrna M. Torres to designate specifically a barangay day wherein the barangay officials can transact with the officials of the Municipality of Tigbauan,

RESOLVED FURTHER, to forward copy of this resolution to the Office of the Municipal Mayor, for the favorable action of the Municipal Mayor, to Office of Association of Barangay Captains and other concerned offices for their Different Councils, for their information.
