RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. SSA -11-04-159, LOT NO. 5447, OCT NO. F-32294 LOCATED AT BARANGAY BITAS, TIGBAUAN, ILOILO OF TRINIDAD TRAGICO ET. AL. OF BARANGAY 3 POBLACION, TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-10-04-159 located at Barangay Bitas, Tigbauan, Iloilo and its supporting documents of TRINIDAD TRAGICO, Et Al was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on November 8, 2004 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last November 8, 2004 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 5447, OCT No. F-32294 with four (4) sub-lots has a total land area of 12,462 square meters more or less;

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;;

WHEREAS, the conditions of said approval shall be the following:

- a. In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b. Comply with all the corrections as indicated on the plans;
- c. Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLRB;

NOW, THEREFORE, on motion of HON. ORVILLO T. TANGENTE, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Alfonsito Estoce,
