RESOLUTION TO AUGMENT SAVINGS FROM PERSONAL SERVICES OF THE LGU-TIGBAUAN, FOR THE GRANT OF ADDITIONAL BENEFITS/CASH GIFTS TO THE MUNICIPAL OFFICIALS AND EMPLOYEES IN THE AMOUNT OF P9,500.00 EACH AUTHORIZED UNDER LBM NO. 2004-45 DATED DECEMBER 9, 2004 AND PRODUCTIVITY INCENTIVE BONUS TO PERMANENT EMPLOYEES WHO HAVE RENDERED SERVICE FOR AT LEAST TWO RATING PERIODS (TO SEMESTERS) FOR THE YEAR 2003 IN THE AMOUNT OF P2,000.00 EACH

WHEREAS, LBM No. 2004-45 clarified the approval for the grant of extra cash gift/additional benefit to officials and employees of LGUs for Fiscal Year 2004;

WHEREAS, the amount of P1,402,000.00 as reflected in the certified savings duly signed by the OIC Municipal Accountant and Municipal Treasurer is available for disbursement for the additional cash gifts/benefits to the Municipal Employees in the amount of P9,500.00 each authorized under LBM No. 2004-45 dated December 9, 2004 and Productivity Incentive Bonus to permanent employees who have rendered service for at least two (2) rating periods (two semesters) for the year 2003 in the amount of P2,000.00 each, chargeable against the savings from personal services of the LGU of Tigbauan, Province of Iloilo;

WHEREAS, the savings from personal services are available to be augmented for the grant of the above-mentioned benefits;

NOW, THEREFORE, upon motion of Hon. Suzette Tenefrancia-Alquisada, Chairman, S.B. Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded unanimously,

RESOLVED, to augment the savings from personal services of the LGU-Tigbauan, in the amount of P1,402,000.00, for the grant of additional benefits/cash gifts to the Municipal Officials and Employees in the amount of P9,500.00 each authorized under LBM No. 2004-45 dated December 9, 2004 and Productivity Incentive Bonus to permanent employee who have rendered service for at least two rating periods (two semesters) for the year 2003 in the amount of P2,000.00 each,
