RESOLUTION APPROVING THE SIMPLE SUBDIVISION APPLICATION NO. SSA -12-04-161, LOT NO. 2-A, 2-B, OCT NO. T-201459, T-179968 LOCATED AT BARANGAY TAN PAEL, TIGBAUAN, ILOILO OF LYDIA CLAROS BULOS OF BARANGAY TAN PAEL, TIGBAUAN, ILOILO

WHEREAS, the Simple Subdivision Application No. SSA-12-04-161 located at Barangay Tan Pael, Tigbauan, Iloilo and its supporting documents of Lydia Claros Bulos, was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on December 6, 2004 for evaluation;

WHEREAS, after the evaluation, the said Simple Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last December 6, 2004 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, Lot No. 2-A, 2-B, OCT No. T-201459, T-179969 with seven (7) lots has a total land area of 6,719 square meters more or less;

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;;

WHEREAS, the conditions of said approval shall be the following:

- a. In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b. Comply with all the corrections as indicated on the plans;
- c. Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d. This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e. This approval does not exempt the proponent from securing registration and license to sell from HLRB;

NOW, THEREFORE, on motion of HON. ORVILLO T. TANGENTE, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Alfonsito Estoce,
