RESOLUTION EXPRESSING THE INTEREST OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN TO PARTICIPATE IN THE JAPAN BANK FOR INTERNATIONAL COOPERATION (JBIC) – FUNDED LOCAL GOVERNMENT UNITS (LGUs) SUPPORT CREDIT PROGRAM IN COOPERATION WITH LAND BANK OF THE PHILIPPINES

WHEREAS, our municipal government has learned of the availability of loan financing from Japan for the construction of water system project or waste disposal project and that this loan will be relent to Local Government Units by Land Bank of the Philippines;

WHEREAS, we are aware that the project promotes full cost of recovery and encourages adoption of commercial principles in the operation of the water system and/or waste disposal system by involving the private sector;

WHEREAS, we are further aware that the participation in the project follows a demand-driven approach whereby Local Government Units shall express interest to participate by sending to Land Bank (LB) a letter of intent together with a Sangguniang Bayan Resolution;

NOW, THEREFORE, on motion of Hon. Alfonsito E. Estoce, Chairman, SB Committee on Infrastructure and General Services and duly seconded by Hon. Jose T. Tavarro and Hon. Jose Donel Trasporto,
