RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPED THROUGH MRS. TERESITA TOLOSA, PRINCIPAL IN CHARGE OF THE DISTRICT (PID), REGARDING THE USE OF CORDOVA ELEMENTARY SCHOOL FOR PROCESSING OF FRESH MILK

WHEREAS, the LGU which was created by law is mandated, as its primary mission, to improve the economic lot of its constituents not only the establishment of development structures but also provisions of economic opportunities wherein the latter could generate revenues with dignity and integrity as well as upliftment of not only their well being, both physical and social, but also their siblings;

WHEREAS, the Iloilo Federation of Dairy Cooperative has chosen the Municipality of Tigbauan as the Center for Milk Processing in the Province of Iloilo;
