RESOLUTION STRONGLY APPEALING TO PNP PROVINCIAL DIRECTOR SR. SUPERINTENDENT EFREN QUINTOS, PROVINCE OF ILOILO, FOR TEN (1) ADDITIONAL PNP PERSONNEL (POLICE OFFICERS) TO REINFORCE AND BOLSTER THE EFFECTIVITY OF THE PNP COMMAND IN THE MUNICIPALITY OF TIGBAUAN

WHEREAS, there is a perceived and urgent need for additional PNP Personnel, to Reinforce the PNP tigbauan Station, which at present has only Twenty Two (22) Personnel;

WHEREAS, the Municipality of Tigbauan has presently a total population of Fifty Five Thousand Eight Hundred Eighty Six (55,886) number of inhabitants that require effective police protection;

WHEREAS, the Municipality of tigbauan has presently a total population of Fifty Five Thousand Eight Hundred Eighty Six (55,886) number of inhabitants that require effective police protection;

WHEREAS, to thwart and curb the incidence of street crimes, and other serious of heinous offences, our need for additional PNP personnel is doenright urgent and immediate;

WHEREAS, recently there were alleged incidence of drug abuse at the Tigbauan national High School and other schools in this town, and also an alleged case of murder and these cases necessitate effective and immediate action by our PNP;

WHEREAS, due to lack of personnel, most if not all PNP Personnel in this Municipality are rendering daily work more than 24 hours- above and beyond the call of duty;

WHEREAS, we have a new Chief of Police, in the person of Police Senior Inspector Ronaldo Planco Palomo, OIC, who apparently has the proper PNP training, intelligence, enthusiasm, dedication, and leadership potentials, that are requisites for effective PNP service, if properly supported;

WHEREAS, with the coming Twon Fiesta of Tigbauan on the 16th of this month, there is an imperative need for more police visibility and effective policing in this place;

NOW, THEREFORE, upon motion of Hon. Romeo T. Ledesma, Vice Chairman, Committee on Good Government, Public Ethics, Accountability and Civil Service and duly seconded by Hon. Pedro T. Rapadas, Chairman, Committee on Peace and Order and Public Safety, Be it

RESOLVED, as we do hereby Resolve, to strongly appeal to PNP Provincial Director Sr. Superintendent EFREN QUINTOS, Province of Iloilo, for Ten (10) additional PNP Personnel (Police Officer) to reinforce and bolster the effectivity of the PNP Command in the Municipality of Tigbauan,
