**Resolution No. 2005-005**

RESOLUTION REALIGNING THE AMOUNT OF TWO HUNDRED THIRTY ONE THOUSAND ONE HUNDRED TEN (P231,110.00) PESOS INTENDED FOR THE CONSTRUCTION OF WELCOME ARC LOCATED AT BRGY. BARROC, TIGBAUAN, ILOILO – FOR THE CONCRETING OF FLOOR SLABS AND FLAG POLE IN FRONT OF THE TIGBAUAN MUNICIPAL BUILDING, CHARGEABLE AGAINST THE 20% IRA DEVELOPMENT FUND – 2003 MUNICIPAL ANNUAL BUDGET.

WHEREAS, as per record in the Office of the Municipal Accountant of Tigbauan, there is a remaining amount of P231,110.00 from the 20% IRA Development Fund – 2003 Municipal Annual Budget which was purposely intended for the Welcome Arc Project;

WHEREAS, since said project will not push through anymore, and in order not to hamper the development of the Municipality of Tigbauan, the Sangguniang Bayan, this municipality is a session assembled, opted to realign said amount (P231,110.00) for the concreting of floor slabs and flag pole in front of the Tigbauan Municipal Building;

NOW, THEREFORE, upon Motion by HON. ALFONSITO E. ESTOCE, Chairman, SB Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Remedios Torrato,

RESOLVED, to realign the Amount Of Two Hundred Thirty One Thousand One Hundred Ten (P231,110.00) Pesos Intended For The Construction Of Welcome Arc Located At Brgy. Barroc, Tigbauan, Iloilo – For The Concreting Of Floor Slabs And Flag Pole In Front Of The Tigbauan Municipal Building, Chargeable Against The 20% Ira Development Fund – 2003 Municipal Annual Budget,
