RESOLUTION ENDORSING THE RENEWAL OF THE QUARRY APPLICATION OF ISAGANI GUANZON LOCATED AT BARANGAY BITAS, TIGBAUAN, ILOILO FOR COMMERCIAL SAND AND GRAVEL PERMIT AND TO THE OFFICE OF THE PROVINCIAL GOVERNOR, PENRO, DENR-REGION VI, AND THE BUREAU OF MINES AND GEOSCIENCES

WHEREAS, Sibalom River within the territorial jurisdiction of the Municipality of Tigbauan, Iloilo has been a good source for sand and gravel materials supplying both commercial and non-commercial infrastructure development in the City and Province of Iloilo;

WHEREAS, Article 100 of the Local Government Code of 1991 empowers the Local Sangguniang Bayan to pass and endorse application permits for commercial sand and gravel at the Sibalom River and for the efficient protection and management of its natural resources;

WHEREAS, the allowance of the quarry extraction at the Sibalom River will enhance the economic condition and livelihood of the people living in the community as well as the Barangay, Municipality and the Province of Iloilo;

NOW, THEREFORE, on motion of HON. ORVILLO T. TANGENTE, Chairman, S.B. Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Alfonsito Estoce and Hon. Remedios Torrato,

RESOLVED, to Favorably Indorse The Renewal Of The Quarry Application Of Isagani Guanzon Located At Barangay Bitas, Tigbauan, Iloilo For Commercial Sand And Gravel Permit And To The Office Of The Provincial Governor, PENRO, DENR-Region VI, And The Bureau Of Mines And Geosciences,
