**Resolution No. 2005-014**

RESOLUTION EXPRESSING INTENTION OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO TO A PARTNERSHIP WITH THE GAWAD KALINGA PROGRAM OF THE COUPLES FOR CHRIST (CFC)

WHEREAS, GAWAD KALINGA, a Filipino term for “PROVIDING CARE” which has been an innate nature of a Filipino to help and to share, has several programs to uplift the dignity of the poor such as shelter, education, health, livelihood, community development, among others;

WHEREAS, GAWAD KALINGA has the following objectives: COMMUNITY DEVELOPMENT, MASSIVE MOBILIZATION FOR VOLUNTEERISM AND PARTNERSHIP IN NATION BUILDING;

WHEREAS, GAWAD KALINGA transforms the idle into productive citizens and builds peaceful, healthy and clean communities;

WHEREAS, GAWAD KALINGA has already four (4) sites of housing project here in the Province of Iloilo initiated by the COUPLES FOR CHRIST and now joined by several organizations, both the government and private sector, namely:

- a.) The CHICAGO VILLAGE in Sto. Niño Sur, Villa, Iloilo City (with 32 houses thru the efforts of Mr. Joe Tigtig of Circulo Tigbaueño International (and adopted by the Couples for Christ in Chicago)
- b.) The Waterfront Village, Jaro, Iloilo City
- c.) The Maryland Village, Mandurriao, Iloilo City
- d.) The relocation site in Municipality of Concepcion

WHEREAS, to address the problem on Social Services including housing and total Community Development to its constituents especially the less-privileged or the poor, is one of the program thrusts of the Local Government Unit of Tigbauan and the municipal officials, headed by the Municipal Mayor, pin their hopes to the Couples for Christ (thru the help of Mr. Rey Ambao and our fellow Tigbaueño, Mr. Joe Tigtig) for the realization of this project;

NOW, THEREFORE, upon motion of HON. ALFONSITO E. ESTOCE, Chairman, Committee on Rules, Ordinances and Resolutions and duly seconded unanimously,
