RESOLUTION FAVORABLY ENDORSING THE APPLICATION FOR DEVELOPMENT PERMIT DP NO. 02-05-001 OF **ROMEO GERONIMO** WITH TCT NO. F-40854, WITH AN AREA OF 240 SQUARE METERS MORE OR LESS, CONTAINING TWENTY SIX (26) LOTS LOCATED AT BRGY. DORONG-AN, TIGBAUAN, ILOILO

WHEREAS, the purpose/intent of this application is to put up a cemetery;

WHEREAS, upon evaluation of facts the said application conform with the standard implementation of E.O. 648;

WHEREAS, the conditions of said approval shall be the following:

- a.) All condition stipulated herein shall form part of the DECISION and are subject to monitoring;
- b.) Non compliance therewith shall be a cause for cancellation of this approval and/or legal action;
- c.) Pertinent provision of E.O. 648 and its implementing Rules and Regulations shall be complied with;
- d.) Submit subdivision plans to the Bureau of Lands/National Land Titles and Deed Registration Administration (LRC) for verification and approval of the field survey returns. Said plans together with the verification/approval documents shall be submitted to HLURB to support application for registration of the subdivision project and the issuance of License to Sell.

WHEREAS, the Preliminary Approval and Locational Clearance was granted by the Office of the Sangguniang Bayan of Tigbauan last December 11, 2004 signed by the Municipal Mayor, Hon. Myrna M. Torres;

WHEREAS, the Municipal Health Office of Tigbauan further issued a certification last November 3, 2003 declaring the above-mentioned lot suitable for the proposed project as per requirements provided by PD 856, Section 90 otherwise known as the Code of Sanitation of the Philippines;

WHEREAS, an Environmental Compliance Certificate was granted by the DENR/EMB, Region VI last March 2, 2004 in favor of the applicant regarding the above-mentioned project;

NOW, THEREFORE, upon motion of HON. ORVILLO T. TANGENTE, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Alfonsito Estoce and Hon. Jose Donel Transporte,

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to Favorably Endorse The Application For Development Permit DP No. 02-05-001 Of **Romeo Geronimo** With TCT No. F-40854, With An Area Of 240 Square Meters More Or Less, Containing Twenty Six (26) Lots Located At Brgy. Dorong-An, Tigbauan, Iloilo,
