**Resolution No. 2005-027**

RESOLUTION APPROVING THE DEFERMENT OF A PORTION OF THE INTERNAL REVENUE ALLOTMENT (IRA) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO CORRESPONDING TO THE INCREASE FROM ITS 2005 SHARE, EXCEPT FOR THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) WHICH SHALL BE USED FOR INFRASTRUCTURE PROJECTS, AND FOR OTHER PURPOSES.

WHEREAS, the League of Municipalities of the Philippines (LMP) at the meeting of the members of its National Directorate in Cebu City on 21 October 2004, passed and approved ND Resolution No. 006-2004 proposing measures to assist the national government in its bid to approve the country's fiscal situation;

WHEREAS, a proposed embodied in ND Resolution No. 006-2004 is for member-municipalities of the LMP to agree to the deferment of the release of the increase in their FY 2005 IRA shares, provided that the national government shall still release the amount of One Million Pesos (P1,000,000.00) out of such IRA increase;

WHEREAS, this Municipality concurs with ND Resolution No. 006-2004 and supports the 10-point legacy of President Gloria Macapagal-Arroyo;

NOW, THEREFORE, premises considered and upon motion of HON. ALFONSITO E. ESTOCE, Chairman, Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Suzette Alquisada, Hon. Alfonso Babiera, Hon. Orvillo Tangente, Hon. Jose Donel Trasporto and Hon. Pedro Rapadas,

RESOLVED, AS IT IS HEREBY RESOLVED, that the Municipality of Tigbauan, Province of Iloilo, hereby adopt ND Resolution No. 006-2004 by Approving the Deferment of a Portion of its IRA Corresponding To The Increase From Its 2005 Share Except For The Amount Of One Million Pesos (P1,000,000.00) Which Shall Be Used For Infrastructure Projects,

RESOLVED FURTHER, that for this purpose, the Department of Budget and Management (DBM) is hereby authorized to defer and withhold the release of the FY 2005 increase in IRA of the Municipality, except for the amount of One Million Pesos (P1,000,000.00) which shall be immediately released,

RESOLVED FURTHERMORE, that the aforementioned amount of One Million Pesos (P1,000,000.00) shall be earmarked and used for the implementation of the Municipality's priority and

much needed infrastructure programs/projects, as follows: (1) concreting of unpaved municipal roads, (2) concreting of access roads to public markets, and (3) concreting of Barangay roads accessible to at least two barangays,

RESOLVED FINALLY, that copies of this resolution be forwarded to the League of Municipalities of the Philippines (LMP), thru its National President, Mayor Ramon N. Guico, Jr., who shall coordinate with the Department of Budget and Management (DBM) on the proper implementation of this resolution, to Hon. DBM Secretary, Emilia T. Boncodin and to Honorable Myrna M. Torres, Municipal Mayor, Tigbauan, Iloilo.
