RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-03-05-168 OF **EMILIA SURIAGA** WITH TCT NO. F-34849, WITH AN AREA OF 1,284 SQUARE METERS MORE OR LESS, CONTAINING TWO (2) LOTS LOCATED AT BRGY. BUYU-AN, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. SA-03-05-168 located at Brgy. Buyu-an, Tigbauan, Iloilo and its supporting documents of Emilia Suriaga was submitted to the Office of the Evaluating Officer, Tigbauan, Iloilo on March 1, 2005 for evaluation;

WHEREAS, after the evaluation, the said Subdivision Application and its supporting documents were forwarded to the Sangguniang Bayan last March 1, 2005 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, TCT No. F-34849 with two (2) lots has a total land area of 1,284 sq. m. more or less;

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;

WHEREAS, the conditions of said approval shall be the following:

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plan;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.

NOW, THEREFORE, upon motion of HON. ALFONSITO ESTOCE and duly seconded by Hon. Suzette Alquisada,

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to approve the Subdivision Application No. SA-03-05-168 Of Emilia Suriaga With TCT No. F-34849, With An Area Of 1,284 Square Meters More Or Less, Containing Two (2) Lots Located At Brgy. Buyu-an, Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this resolution to the Office of the Municipal Mayor, Tigbauan, Iloilo for his information and appropriate action, Land Management Sector, DENR, Region VI, Iloilo City for their verification and approval of its field survey returns, and to the HLURB, Iloilo City to support said application for registration of the subdivision.
