RESOLUTION FAVORABLY ENDORSING THE QUARRY APPLICATION OF MR. DEMETRIO TIEZO TO QUARRY EARTH SOIL LOCATED AT BARANGAY GUISIAN, TIGBAUAN, ILOILO FOR COMMERCIAL EARTH QUARRY PERMIT AND TO THE OFFICE OF THE PROVINCIAL GOVERNOR, PENRO, DENR-REGION VI, AND THE BUREAU OF MINES AND GEOSCIENCES

WHEREAS, Barangay Guisian is within the territorial jurisdiction of the Municipality of Tigbauan, Iloilo has been a good source for earth soil materials supplying both commercial and non-commercial infrastructure development in the City and Province of Iloilo;

WHEREAS, Article 100 of the Local Government Code of 1991 empowers the Local Sangguniang Bayan to pass and endorse application permits for commercial earth quarry and for the efficient protection and management of its natural resources;
