RESOLUTION URGENTLY REMINDING OUR FIRE MARSHALL AND ALL BUREAU OF FIRE PROTECTION (BFP) PERSONNEL TO KEEP IN GOOD CONDITION OUR FIRE TRUCK AND ALL FIRE-FIGHTING EQUIPMENT AND REQUESTING OUR GOOD MAYOR/ACTING MAYOR AND ALL CONCERNED LGU PERSONNEL TO **GIVE PRIORITY TO THE NEEDS OF OUR LOCAL BFP** TO ENABLE THEM TO READILY RESPOND WITHIN THE FIRST THREE (3) CRUCIAL MINUTES AFTER ANY EMERGENCY CALL- WHICH IS THE CARDINAL RULE IN ALL EFFECTIVE FIRE-FIGHTING.

WHEREAS, a fire of undetermined origin had razed the three (3) buildings of the Red Gold Aqua Venture – a Hatchery located at Barangay Tan Pael, this municipality, sometime in the afternoon of March 20, 2005;

WHEREAS, allegedly our local BFP was delayed in responding because a part of our fire-fighting equipment was not fully repaired due allegedly to fiscal constraint;

WHEREAS, another alleged cause of the delay to respond immediately was because our Fire Truck had to gas-up first at the Local Caltex Station before proceeding to the fire scene;

WHEREAS, all LGU officials and employees concerned should set aside enough logistical support for our BFP personnel, and that their requests for assistance should be facilitated with the least possible delay;

WHEREAS, our BFP personnel are advised and enjoined to keep the fuel tank and water tank of our Fire Truck in full capacity all the time, in order to avoid any delay, and to prevent the possible embarrassment to this LGU if Fire Trucks from other towns shall be the first to respond to our local fire problem;

WHEREAS, as a result of the destructive fire that burned down the Red Gold Aqua Venture Hatchery above-stated, the hatchery workers who are all from Sitio Little Tondo, Barangay Buyu-an, this municipality, have lost their source of livelihood;

NOW, THEREFORE, upon motion of HON. ROMEO T. LEDESMA and duly seconded by Hon. Suzette Alquisada, Be It

RESOLVED, as we do hereby resolve to urgently remind our Fire Marshall And All Bureau Of Fire Protection (BFP) Personnel To Keep In Good Condition Our Fire Truck And All Fire-Fighting Equipment And Requesting Our Good Mayor/Acting Mayor And All Concerned LGU Personnel To Give Priority To The Needs Of Our Local BFP To Enable Them To Readily Respond Within The First Three (3) Crucial Minutes After Any Emergency Call- Which Is The Cardinal Rule In All Effective Fire-Fighting,
