WHEREAS, the residents of Barangay Bagacay, this municipality, had long desired of a secondary school in their Barangay because the national high school where high students from the said Barangay enroll is very far thus the schoolchildren had to experience too much difficulty in their studies especially during rainy season/bad weather;

WHEREAS, being at the center of a cluster of barangays in the southwest and northwest corners of this municipality, Brgy. Bagacay is a good or appropriate site for a secondary school to serve students from the said Barangay and neighboring barangays as well;

WHEREAS, the establishment of a secondary school in Brgy. Bagacay is highly beneficial (not only to students of the said Barangay but also to students of the neighboring barangays, namely, Barangay Cansilayan, Supa, Bugasongan, Danao and Guisian) in many aspects in terms of money, time and effort;

WHEREAS, graduates of Bagacay Elementary School and Danao Elementary School will also be absorbed by this secondary school once it will be established in Brgy. Bagacay;

WHEREAS, the Barangay officials and residents of Brgy. Bagacay pin their hopes to the good Governor for the realization of this felt-need project considering that the Barangay has no sufficient funds for this project;
