WHEREAS, Section 447 of the Local Government Code (RA No. 7160) provides that “*The Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants*”;

WHEREAS, to have a basis for the resolutions and ordinances, the Sangguniang Bayan must be apprised of the financial status of the municipality;

WHEREAS, the newly elected and re-elected members of the Sangguniang Bayan are at the quandary as to the financial status of the municipality;

WHEREAS, the offices of the Municipal Budget Officer and the Municipal Accountant are in charge of recording of the financial transactions of the municipality;

NOW, THEREFORE, upon motion of HON. ROEL T. JARINA, and duly seconded by Hon. Jose Donel Trasporto, Hon. Romeo Ledesma, Hon. Orvillo Tangente and Hon. Alfonso Babiera,
