RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM GOVERNOR NIEL D. TUPAS FOR THE CONSTRUCTION OF BREAKWATER, BARANGAY 8 TO PREVENT OCCURRENCE OF FLASHFLOODS WHICH MAY DAMAGE RESIDENTIAL HOUSES/BUILDINGS.

WHEREAS, Barangay 8 of the Municipality of Tigbauan is a coastal Barangay wherein most of the inhabitants reside near the shoreline;

WHEREAS, during rainy season, because of the high tide, the residents of Barangay 8 usually experience flooding in their Barangay;

WHEREAS, there is a need to construct a breakwater at Barangay 8, however, the Municipality of Tigbauan is financially constrained and has no available funds to finance the project;

WHEREAS, there is a need for the financial assistance from the Provincial Government in order that the above project will be implemented to prevent flashfloods which may result to more damages and serious problems in Barangay 8, in the near future;

NOW, THEREFORE, on motion of HON. SUZETTE T. ALQUISADA, and duly seconded by Hon. Alfonsito Estoce and Hon. Romeo Ledesma,

RESOLVED, to request Financial Assistance From Governor Niel D. Tupas For The Construction Of Breakwater, Barangay 8 To Prevent Occurrence Of Flashfloods Which May Damage Residential Houses/Buildings,

RESOLVED FURTHER, to forward a copy of this Resolution to Hon. Niel D. Tupas, Provincial Governor, Province of Iloilo for his information and immediate action.
