**Resolution No. 2005-048**

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HER EXCELLENCY PRESIDENT GLORIA MACAPAGAL-ARROYO THROUGH JANET OBERIO, DIRECTOR, PHILIPPINE CHARITY SWEEPSTAKES OFFICE, REGION 6, ILOILO CITY FOR THE CONSTRUCTION OF A BRIDGE FROM BARANGAY 1 TO SITIO DOROG-BARANGAY DORONG-AN, TIGBAUAN, ILOILO.

WHEREAS, Sitio Dorog-Barangay Dorong-an is one of the 52 Barangays composing the Municipality of Tigbauan;

WHEREAS, Sitio Dorog-Barangay Dorong-an are mostly farmers and 70% of their income is derived from agricultural products which they transport from the farm to be sold to the Municipal Public Market;

WHEREAS, during rainy season, the Sibalom River is impassable by foot and that transportation of farm products is difficult and the residents find it to go to the Poblacion for their necessities and emergencies which need immediate medical attention;

WHEREAS, there is a need to construct a bridge which will link Sitio Dorog-Barangay Dorong-an to the Poblacion, passing through Barangay 1 of the Poblacion, in order to help uplift the financial status of the inhabitants of the said Barangay by making such Barangay accessible to transport farm products and other needs of the inhabitants;

WHEREAS, the Municipality of Tigbauan is financially constraint and has no available funds to finance the construction of such project;

WHEREAS, there is a need for financial assistance from Her Excellency President Gloria Macapagal-Arroyo through Mrs. Janet Oberio, Director, Philippine Charity Sweepstakes Office, Region 6, Iloilo City for the construction of the above named project;

NOW, THEREFORE, on motion of HON. SUZETTE T. ALQUISADA, Chairperson, Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded unanimously,

RESOLVED, to request Financial Assistance From Her Excellency President Gloria Macapagal-Arroyo Through Janet Oberio, Director, Philippine Charity Sweepstakes Office, Region 6, Iloilo City For The Construction Of A Bridge From Barangay 1 To Sitio Dorog-Barangay Dorong-an, Tigbauan, Iloilo.
