RESOLUTION STRONGLY INDORSING TO HON. JERRY TREÑAS, CITY MAYOR, ILOILO CITY THRU HON. JOSE ESPINOSA III, CHAIRMAN, SP COMMITTEE ON TRAFFIC, FOR FAVORABLE ACTION THE APPEAL OF THE TIGBAUAN JEEPNEY OWNERS AND DRIVERS ASSOCIATION (TJODA) TO BE CONSIDERED AS MOBILE PROVINCIAL PUJs WITH REGARD TO THE IMPLEMENTATION OF THE CITY REGULATION ORDINANCE NO. 2004-408 (REFERRING TO PERIMETER BOUNDARY TERMINAL WITH ALL PROVINCIAL VEHICLES).

WHEREAS, the Sangguniang Bayan of Tigbauan, Iloilo believes in the wisdom of the City Ordinance No. 2004-408 (known as the Perimeter Boundary Terminal with all Provincial Vehicles) in solving the worsening traffic situation of the city;

WHEREAS, with the implementation of this Perimeter Boundary Terminal With All Provincial Vehicles, the 36 units public utility vehicles plying Tigbauan-Iloilo City and vice versa will be greatly affected in terms of the drivers already dwindling daily income that could hardly support their family;

WHEREAS, government workers, students and private employees will have to pay higher fare rates, further draining their pockets of the much needed money as well as the delay in time in reporting to their offices and schools;

WHEREAS, the commuting lowly fish and vegetable vendors will barely be able to feed their family because much of their profits go to operational expenses such as higher fare rates and handling expenses causing a domino effect to the consumers resulting to higher prices of the commodities;

WHEREAS, the Municipality of Tigbauan is equidistant with the Municipality of Zarraga from the city hence this appeal to consider the Tigbauan Jeepney Owners and Drivers Association (TJODA) as part of the Mobile Provincial PUJs like the Zarraga Jeepney Owners and Drivers Association;

NOW, THEREFORE, on motion of HON. JOSE TAVARRO, JR., Chairman, Committee on Transportation, Communication and Energy and duly seconded unanimously,
