**Resolution No. 2005-052**

RESOLUTION ASKING FOR FINANCIAL ASSISTANCE FROM SENATOR MAR ROXAS, HOUSE OF  
SENATE, MANILA, THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00)FOR THE REPAIR AND  
REHABILITATION OF THE TIGBAUAN PUBLIC MARKET, MUNICIPALITY OF TIGBAUAN,  
PROVINCE OF ILOILO.

WHEREAS, the Municipality of Tigbauan is a component town of the Province of Iloilo with 52  
barangays, having a population of 54,435 inhabitants as of 2002 census and with 32,282 registered voters as of  
May 10, 2004;

WHEREAS, the Municipality of Tigbauan has a rapid expanding population and it badly needs an  
improved and spacious market for its populace;

WHEREAS, the Tigbauan Public market was constructed way back 1950s yet and is now very  
dilapidated;

WHEREAS, because of limited sources of funds, repair and maintenance of the market building and  
facilities are fast deteriorating resulting to leaking of roofs, torn or broken walls, very poor ventilation and  
lighting, poor drainage system and inadequate water supply;

WHEREAS, the Municipal Government of Tigbauan, much to its desire to undertake the major repair  
and rehabilitation of the Tigbauan Public Market, could not possibly make it unless it can have other sources of  
funds;

WHEREAS, the municipal officials pin down their hopes on Senator Mar Roxas for the realization of  
the project;

NOW, THEREFORE, on motion of HON. JOSE T. TAVARRO, JR., Chairman, Committee on Market  
and Slaughterhouse and duly seconded unanimously,

RESOLVED, to ask For Financial Assistance From Senator Mar Roxas, House Of Senate, Manila, The Amount Of Five Million Pesos (P5,000,000.00)For The Repair And Rehabilitation Of The Tigbauan Public Market, Municipality Of Tigbauan, Province Of Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Senator Mar Roxas, House of Senate, Manila, for his information and appropriate action and to Hon. Myrna M. Torres, Municipal Mayor, Tigbauan, Iloilo, for her proper information and guidance.
