WHEREAS, the Tigbauan Municipal Building was constructed wayback in the early 60's and some of its portions are already very dilapidated by use and age;

WHEREAS, hundreds if not thousands of people flock in the said building especially during affairs/celebrations and/or activities of the municipality and even during working days of the week to facilitate not only official but all kinds of transactions;

WHEREAS, the past and present administration had also initiated some urgent repairs and improvements on the said building but due to insufficiency of funds, until now some portions of its roof are still leaking aside from other major repairs and improvements which need to be made as early as possible;

WHEREAS, for the interest of an efficient and effective public service and for the safety of our people, the officials of this municipality pin down their hopes to the good senator for the improvement and/or renovation of the Tigbauan Municipal Building;
