WHEREAS, the Rural Health Center has been catering to the health needs of the 54,854 population of this municipality as of the last census;

WHEREAS, the building which was constructed a long time ago made of wood and concrete materials had likewise become too dilapidated and some parts had been eaten and destroyed by termites causing the rainwater to leak and making it dangerous to the health personnel and the public as well as soiling the records;

WHEREAS, the municipal government has limited funds to finance its repair, thus the need to look for other sources of funds;

NOW, THEREFORE, upon motion of HON. JOSE TAVARRO, JR., Vice Chairman, Committee on Health and Sanitation and was unanimously seconded, Be It
