RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM SENATOR PIA “COMPÀNERA” CAYETANO FOR THE CONSTRUCTION OF DAPDAP HEALTH CENTER, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Tigbauan which has a population of 54,854 as of the last census, has a main health center located in the heart of the town;

WHEREAS, Tigbauan has 11 health sub-stations and one of which is Dapdap Health Center;

WHEREAS, Dapdap Health Center, which is located 8 kilometers northwest of Tigbauan, is catering 7 barangays of the municipality;

WHEREAS, Dapdap Health Center is catering about 3,580 constituents of the barangays;

WHEREAS, Dapdap Health Center, which was constructed 2 decades ago, is made of bamboo and nipa and is very dilapidated and needs to be repaired;

WHEREAS, the Local Government Unit of Tigbauan has limited funds to finance the repair of Dapdap Health Center, thus the need to request for financial assistance;

NOW, THEREFORE, on motion of HON. ROEL T. JARINA, Chairman, Committee on Health and Sanitation and unanimously seconded, Be It

RESOLVED, to request Financial Assistance From Senator Pia “Compañera” Cayetano For The Construction Of Dapdap Health Center, Municipality Of Tigbauan, Province Of Iloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Pia Cayetano, Senator of the Republic, Hon. Myrna M. Torres, Municipal Mayor, Tigbauan, Iloilo and to all concerned for their information, guidance and/or appropriate favorable action.
