**Resolution No. 2005-061**

RESOLUTION FOR AUGMENTATION OF FUNDS FOR PAYMENT OF EDUCATIONAL ASSISTANCE FOR FY 2005 TO MUNICIPAL OFFICIALS AND EMPLOYEES, LOCAL GOVERNMENT UNIT OF TIGBAUAN, PROVINCE OF ILOILO, AT ONE THOUSAND PESOS (P1,000.00) EACH WITH THE TOTAL AMOUNT OF ONE HUNDRED TWENTY TWO THOUSAND PESOS (122,000.00) TO BE TAKEN FROM THE SALARY SAVINGS OF THE MUNICIPAL ACCOUNTANT, OFFICE OF THE MUNICIPAL ACCOUNTANT, FROM JANUARY 1 TO JUNE 30, 2005.

WHEREAS, Administrative Order No. 120 dated June 7, 2005 authorizes the grant of Educational Assistance to government personnel for FY 2005 in recognition of their contributions in providing quality service despite the government's austerity measures and to help them cope with rising cost of education;

WHEREAS, DBM Budget Circular No. 2005-03 provides the rules and regulations to implement Administrative Order No. 120;

WHEREAS, qualified government personnel under DBM Circular No. 2005-03 shall be entitled to receive the educational assistance in the amount of one thousand pesos (P1,000.00) each and under Section 7 of the said circular provides that payment of educational assistance shall be made immediately;

WHEREAS, the Municipal Budget Officer issued a certification that the amount of ONE HUNDRED TWENTY TWO THOUSAND PESOS (P122,000.00) is available for granting of educational Assistance for FY 2005 per Administrative Order No. 120, dated June 7, 2005 to be taken from the salary savings of the Municipal Accountant, Office of the Municipal Accountant, LGU Tigbauan, from January 1 to June 30, 2005, such certification was duly noted by Hon. Agaton O. Tumabotabo, Acting Municipal Mayor on July 1, 2005;

NOW, THEREFORE, on motion of HON. ALFONSO C. BABIERA, Vice Chairman, Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded unanimously; BE IT

RESOLVED, AS THE SANGGUNIANG BAYAN HEREBY RESOLVES, that the savings from Personal Services – salary of the Municipal Accountant, Office of the Municipal Accountant from January 1 to June 30, 2005 in the amount of One Hundred Twenty Two Thousand Pesos (P122,000.00) be augment for payment of the grant of Educational Assistance for FY 2005 per Administrative Order No. 120 dated June 7, 2005 to the municipal officials and employees of the Municipality of Tigbauan, Province of Iloilo;

RESOLVED FURTHER, that the Office of the Hon. Mayor Myrna Torres, Office of the Municipal Budget Officer, Office of the Municipal Accountant and Office of the Municipal Treasurer shall be furnished copies of this Resolution for their information, guidance and appropriate action.
