RESOLUTION DECLARING THE TABLES, CHAIRS AND OTHER FURNITURES AND FIXTURES IN THE OFFICE OF THE SANGGUNIANG BAYAN FOR OFFICIAL USE OF THE SANGGUNIANG BAYAN OFFICIALS AND PERSONNEL AND PROHIBITING ANY PERSON FROM TAKING/REMOVING AND BRINGING SUCH PROPERTIES OUTSIDE THE OFFICE OF THE SANGGUNIANG BAYAN

WHEREAS, Art. 100 (x) of the Rules and Regulations Implementing the Local Government Code of 1991, mandates that the Sangguniang Bayan shall: “Provide a mechanism and appropriate funds therefore, to ensure the safety and protection of all municipal government property, public documents, or records such as those relating to property inventory, land ownership, records of births, marriages, death, assessment, taxation, accounts, business permits and such other records and documents of public interest in the offices and departments of the municipal government.”;

WHEREAS, it has been the experience in the past years that the tables, chairs and other furnitures and fixtures of the Office of the Sangguniang Bayan were being used outside the municipal building and even brought to the plaza whenever there were public functions and programs;

WHEREAS, the taking thereof of such furnitures and fixtures from the Office of Sangguniang Bayan, resulted to the deterioration and damage of the above-mentioned properties;

WHEREAS, there is a need to ensure that tables, chairs, furnitures and fixtures and other government properties, specifically those in the Office of the Sangguniang Bayan, be protected from deterioration and damage in order to utilize fully and extend the economic life of said properties;

NOW, THEREFORE, on motion of HON. SUZETTE TENEFANCIA-ALQUISADA, SB Chairman of the Committee on Appropriations, Budget, Finance, Accounts and Legal Matters and Chairman, on Good Government, Public Ethics, Accountability and Civil Service and unanimously seconded; BE IT

RESOLVED, to declare the Tables, Chairs And Other Furnitures And Fixtures In The Office Of The Sangguniang Bayan For Official Use Of The Sangguniang Bayan Officials And Personnel And Prohibiting Any Person From Taking/Removing And Bringing Such Properties Outside The Office Of The Sangguniang Bayan,

RESOLVED FURTHER, to furnish copies of this resolution to the Office of the Municipal Mayor, and other concerned offices for their information, guidance and appropriate action.
