RESOLUTION FOR AUGMENTATION OF FUNDS FOR PAYMENT OF RATA DIFFERENTIAL OF MUNICIPAL OFFICIALS, HEADS AND ASST. HEADS OF OFFICES FROM APRIL 1 TO DECEMBER 31, 2005 IN THE AMOUNT OF THREE HUNDRED TWENTY SIX THOUSAND THIRTY FOUR PESOS (P326,034.00) TO BE TAKEN FROM SAVINGS ON PERSONAL SERVICES OF SUPPLEMENTAL BUDGET IN THE LGU OF TIGBAUAN, ILOILO

WHEREAS, Local Budget Circular No. 79 issued by the Department of Budget and Management dated April 1, 2005, provided for guidelines for the implementation of the revised rates of representation and transportation allowances (RATA) in Local Government Units;

WHEREAS, the Honorable Sangguniang Bayan of this municipality has already passed Resolution No. 2005-050 implementing Local Budget Circular No. 79 dated April 1, 2005;

WHEREAS, Municipal Budget Officer has issued a certification that the amount of Three Hundred Twenty Six Thousand Thirty Four Pesos (P326,034.00) is available for augmentation for payment of RATA differential of Municipal Officials, Heads and Assistant Heads of offices from April 1 to December 31, 2005 to be taken from Savings in Personal Services of Supplemental Budget No. 2005-01 of the Local Government of Tigbauan, Iloilo, Philippines, which was duly noted by Hon. Agaton O. Tumabotabo, Acting Municipal Mayor dated July 26, 2005;

NOW, THEREFORE, on motion of HON. SUZETTE T. ALQUISADA, Chairman, Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded unanimously; Be It

RESOLVED, as the Sangguniang Bayan hereby resolves, that the Amount Of Three Hundred Twenty Six Thousand Thirty Four Pesos (P326,034.00) be augmented for payment of RATA Differential of Municipal Officials, Heads and Assistant Heads of Offices from April 1 to December 31, 2005 To Be Taken From Savings On Personal Services Of Supplemental Budget In The LGU Of Tigbauan, Iloilo, Philippines;
