RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-08-05-178 OF VICTOR TAJANLANGIT WITH TCT NO. T-176,360, LOT 782-B-2-B WITH AN AREA OF 300 SQ. M. MORE OR LESS, CONTAINING TWO (2) LOTS LOCATED AT BRGY. ATABAYAN, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. SA-08-05-178 located at Brgy. Atabayan, Tigbauan, Iloilo and its supporting documents of Victor Tajanlangit was submitted to the Office of the Evaluating Officer, Tigbauan, Iloilo on August 3, 2005 for evaluation;

WHEREAS, after evaluation, the said Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last August 3, 2005 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, TCT No. TCT-176,360 with two (2) lots has a total land area of 300 square meters more or less;

WHEREAS, the purpose/intent of this application is to sell;

WHEREAS, the conditions of said approval shall be the following:

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plan;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.

NOW, THEREFORE, on motion of HON. ORVILLO T. TANGENTE, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Jose Donel Trasporto, and Hon. Alfonsito Estoce,

RESOLVED, to approve the Subdivision Application No. SA-08-05-178 Of Victor Tajanlangit With TCT No. T-176,360, Lot 782-B-2-B With An Area Of 300 Sq. M. More Or Less, Containing Two (2) Lots Located At Brgy. Atabayan, Tigbauan, Iloilo,
