RESOLUTION EARNESTLY APPEALING TO GOVERNOR NIEL D. TUPAS, PROVINCE OF ILOILO FOR THE REPAIR AND MAINTENANCE OF PARARA-JAMOG ROAD, MUNICIPALITY OF TIGBAUAN LINKING LEON AND TUBUNGAN PROVINCIAL ROAD, PROVINCE OF ILOILO

WHEREAS, due to the bad condition of Parara-Jamog-Leon-Tubungan Provincial Road, we urgently appeal to Gov. Niel D. Tupas, Province of Iloilo for its emergency repair and maintenance through surfacing;

WHEREAS, the said road is dangerous to the lives and properties of the riding public because it is badly damaged resulting from the occurrence of heavy rain;

WHEREAS, because of its bad condition, the drivers of the Public Utility Vehicles (PUVs), Jeepneys and Tricycles of this Municipality plying said route, are planning to boycott transportation if said road is not immediately repaired;

WHEREAS, the boycott of transportation by the drivers will certainly redound to economic problem of our barangays as well as of our municipality;

NOW, THEREFORE, on motion of HON. ALFONSITO E. ESTOCE, Chairman, Committee on Infrastructure and General Services and duly seconded unanimously,
