RESOLUTION REQUESTING HON. HILARIO DAVIDE, JR., CHIEF JUSTICE, SUPREME COURT
TO CREATE A SEPARATE MUNICIPAL TRIAL COURT IN THE MUNICIPALITY OF
TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the 15th Municipal Circuit Trial Court (MCTC); 6th Judicial Region, is currently
serving the Municipalities of Tubungan, Guimbal, Igbaras, and Tigbauan with only one judge assigned
and holds office only in the Municipality of Tigbauan, every Friday of the week;

WHEREAS, of the total number of cases pending in the 15th MCTC, majority of the cases comes
from Tigbauan, compared to the cases from Guimbal, Igbaras and Tubungan combined;

WHEREAS, before the reorganization of the Judiciary, during the time of the Late Judge Jose
Tavarro, Sr., there existed a municipal court in Tigbauan, however, it was abolished when the Judiciary
was reorganized;

WHEREAS, to attain speedy disposition of the cases as mandated by our Constitution, there is a
need to create a separate Municipal Trial Court in the Municipality of Tigbauan, Province of Iloilo,
Philippines;

NOW, THEREFORE, on motion of HON. SUZETTE T. ALQUISADA, Chairperson,
Committee on Budget, Finance, Accounts and Legal Matters and duly seconded unanimously,

RESOLVED, to request Hon. Hilario Davide, Jr., Chief Justice, Supreme Court To Create A
Separate Municipal Trial Court In The Municipality Of Tigbauan, Province Of Iloilo,

RESOLVED FURTHER, to forward a copy of this Resolution to Hon. Hilario Davide, Jr., Chief Justice, Supreme Court for his appropriate action and to the following for their information and guidance.
