## Resolution No. 2005-077

RESOLUTION EXPRESSING HEARTFELT SYMPATHY AND PROFOUND GRATITUDE TO THE BEREAVED FAMILY OF THE LATE **MR. RICARDO T. TANTIADO** FOR HIS SUPERB SERVICES IN VARIOUS CAPACITIES HE HAD RENDERED TO THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the late Mr. Ricardo Tranca Tantiado suddenly passed away last August 29, 2005;

WHEREAS, the late Mr. Ricardo T. Tantiado, during his lifetime, had been an active force and a prime mover in the civic and religious affairs of Tigbauan;

WHEREAS, as a Renaissance man gifted by God with a keen intellect, and always bubbling with bright ideas, the late Mr. Tantiado believed in the Biblical adage that "...to whom God has given so much, so much of him is to be expected";

WHEREAS, being active on Boy Scout movement, he gave honor to Tigbauan as one of the BSO Officials who led the Iloilo contingent to the First World Boy Scout Jamboree in the Philippines, held at the Mt. Makiling National Park in 1958, attended by thousands of Boy Scouts from countries all over the world; and he was a member of the BSP Iloilo Provincial Executive Board (1970-1975), and also a Member of the Rover Scout International Asia-Pacific Training Team;

WHEREAS, Mr. Tantiado has served as Director of ILECO I Board (1974-1979), also as Member of the Board of Directors of the province-wide Iloilo Public School Teachers Association (1965-1972), and as President of the TNHS Parents-Teachers & Community Association (1993-1994), among others;

WHEREAS, he was the founding father of the Knights of Columbus Council No. 6070 in Tigbauan, and its first Grand Knight, and had been President of our Parish Pastoral Council, among other;

WHEREAS, during the terms of several Municipal Mayors, the late Mr. Tantiado has served in various capacities, as Chairman of NGO bodies such as PEC, the BARC, the MAFC, the LWUA, and most notably as Member of our Municipal Development Council (MDC), all with telling effect, being deeply involved in, and committed to, the development of Tigbauan;

WHEREAS, having consecrated his life to the noblest profession of all – which is teaching, the late Mr. Tantiado had started at Tigbauan Elementary School, and retired at West Visayas State University (WVSU) where he took his MA in Education degree, and where he authored and published several Elementary and Secondary Curriculum Textbooks, which are used by Grade IV to Grade VI Pupils, and by 1<sup>st</sup> year to 4<sup>th</sup> year students, respectively;
