RESOLUTION REQUESTING THE MUNICIPAL MAYOR/ACTING MUNICIPAL MAYOR AND MUNICIPAL ENGINEER TO FAST-TRACK THE REPAIR AND THE SETTING UP OF THE MUNICIPAL CIRCUIT TRIAL COURT, THIS MUNICIPALITY.

WHEREAS, the Office/Courtroom of the Municipal Trial Court in this municipality was transferred to the conference room when the Office of the Sangguniang Bayan was renovated and expanded;

WHEREAS, from the time of the transfer of the courtroom of the Municipal Circuit Trial Court of this Municipality to the conference room, the said conference room was not repaired and set-up as a courtroom to accommodate the hearing of the cases here in the municipality, hence, the hearing of the cases in our municipality was not conducted here but in the Courtroom at Guimbal, Iloilo;

WHEREAS, this August Body has passed a resolution requesting Hon. Hilario Davide Jr., Chief Justice of Supreme Court to create a separate Municipal Circuit Trial Court in the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, in order to attain speedy disposition of the cases in our municipality, it is imperative that the conference room be repaired and set-up as a courtroom to accommodate the hearing of the cases of the 15th Municipal Circuit Trial Court here in the Municipality of Tigbauan;

NOW, THEREFORE, upon motion of HON. SUZETTE T. ALQUISADA, Chairperson, Committee on Budget, Finance, Accounts, and Legal Matters and duly seconded unanimously,

RESOLVED, to request the Municipal Mayor/Acting Municipal Mayor And Municipal Engineer To Fast-Track The Repair And The Setting Up Of The Municipal Circuit Trial Court, This Municipality,

RESOLVED FURTHER, to forward copies of this Resolution to the Municipal Mayor/Acting Municipal Mayor and Municipal Engineer for their appropriate and immediate action.
