**Resolution No. 2005-082**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. MYRNA M. TORRES/ACTING MUNICIPAL MAYOR AGATON O. TUMABOTABO, ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, ILOILO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LOCAL GOVERNMENT UNIT OF BAROTAC VIEJO REPRESENTED BY HON. MAYOR RAUL C. TUPAS REGARDING THE IMPLEMENTATION OF THE PROGRAM ENTITLED: “NUTRI PLANT TO COMBAT MALNUTRITION FOR RURAL TRANSFORMATION”.

WHEREAS, the Provincial Local Government of Iloilo recognizes that Municipalities in the Province of Iloilo with incidence of malnutrition are faced with huge budgetary constraints to combat malnutrition through quality feeding, hence, encourage sponsorship arrangements through participation to help the malnourished children who belong to poor families;

WHEREAS, the program of “Nutri Plant to Combat Malnutrition for Rural Transformation” will be undertaken by the Provincial Local Government of Iloilo, under the leadership of the Hon. Niel D. Tupas, Sr. In partnership with the Local Government of Barotac Viejo;

WHEREAS, the Memorandum of Agreement shall embody undertakings of the Municipality of Barotac Viejo to produce a Fish Protein Concentrate and by products duly accredited by BFAD to be distributed to the Municipality of Tigbauan and it shall conduct an orientation relative to the implementation of the program and provide technical support services for the implementation and administration of the program;

WHEREAS, the Municipality of Tigbauan shall allocate funding in the amount of P12,399.40 as equity to buy products being produced by the Barotac Viejo Nutri Plant and to be distributed to the affected Barangays of Tigbauan. The equity represents thirty percent (30%) of the cost of project, which is shouldered by the Municipality of Tigbauan and the seventy percent (70%) shall be shouldered by the Provincial Government of Iloilo;

NOW, THEREFORE, on motion of HON. SUZETTE T. ALQUISADA, and duly seconded by Hon. Jose T. Tavarro, Jr. And Hon. Jose Donel Trasporto,

RESOLVED, as it is hereby resolved, to authorize The Municipal Mayor, Hon. Myrna M. Torres/Acting Municipal Mayor Agaton O. Tumabotabo, On Behalf Of The Local Government Unit Of Tigbauan, Iloilo, To Enter Into A Memorandum Of Agreement With The Local Government Unit Of Barotac Viejo Represented By Hon. Mayor Raul C. Tupas Regarding The Implementation Of The Program Entitled: “Nutri Plant To Combat Malnutrition For Rural Transformation”,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Mayor Myrna M. Torres/Hon. Agaton O. Tumabotabo, Acting Municipal Mayor, and to all concerned for their proper information and/or appropriate action.
