RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-09-05-181 OF ERNA T. SENOSA ET-AL WITH TCT NO. T-10,901, LOT NO. 3503 WITH AN AREA OF 1,157 SQUARE METERS MORE OR LESS, CONTAINING TWO (2) LOTS LOCATED AT BRGY. PARARA SUR, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. SA-09-05-181 located at Brgy. Parara Sur, Tigbauan, Iloilo and its supporting documents of ERNA T. SENOSA ET AL was submitted to the Office of the Evaluating Officer, Tigbauan, Iloilo on October 3, 2005 for evaluation;

WHEREAS, after the evaluation, the said Subdivision Application and its supporting documents were forwarded to the Sangguniang Bayan last October 3, 2005 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, TCT No. T-10,901 with two (2) lots has a total land area of 1,157 sq. m. more or less;

WHEREAS, the purpose/intent of this application is to sell;

WHEREAS, the conditions of said approval shall be the following:

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plan;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.

NOW, THEREFORE, upon motion of HON. JOSE DONEL TRASPORTO, (*under the sponsorship of Hon. Orvillo T. Tangente, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation*) and duly seconded by Hon. Romeo Ledesma,

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to approve the Subdivision Application No. SA-09-05-181 Of Erna T. Senosa Et-Al With TCT No. T-10,901, Lot No. 3503 With An Area Of 1,157 Square Meters More Or Less, Containing Two (2) Lots Located At Brgy. Parara Sur, Tigbauan, Iloilo,
