RESOLUTION AUTHORIZING MR. EDWIN L. PIROTE, PROJECT EVALUATION OFFICER, BUREAU OF LOCAL GOVERNMENT FINANCE (BLGF), AS ONE OF THE SIGNATORIES FOR THE CHECKS ISSUED BY THE MUNICIPALITY OF TIGBAUAN IN ALL BANKS INSTRUMENTALITIES: WITH THE PHILIPPINE NATIONAL BANK (PNB), LAND BANK OF THE PHILIPPINES (LBP) AND OTHER BANKING INSTITUTIONS DURING HIS TERM AS OIC, OFFICE OF THE MUNICIPAL TREASURER, LGU-TIGBAUAN, ILOILO.

WHEREAS, **MEMORANDUM NO. 011, S. 2005** was issued by Mayor Myrna Montealegre Torres, designating Mr. Edwin L. Pirote, Project Evaluation Officer IV, BLGF, as Officer-In-Charge, Office of the Municipal Treasurer, LGU-Tigbauan, Iloilo effective **October 21, 2005** up to but not beyond a period of six (6) months, or until sooner revoked – in lieu of Mr. Manuel T. Tabalada, Jr., who was relieved of his duties and functions as Municipal Treasurer;

WHEREAS, in a letter dated October 21, 2005, Mayor Myrna M. Torres requested this August Body for the urgent passage of this resolution so that Mr. Edwin L. Pirote will be authorized to be one of the signatories of checks issued by the municipal government for payments of expenses and disbursement of funds;

WHEREAS, to ensure efficient and effective public service and in order that the transaction of this municipal government will not be paralyzed, it is imperative that this August Body shall therefore urgently pass this needed resolution;

NOW, THEREFORE, on motion of HON. SUZETTE T. ALQUISADA, Chairman, S.B. Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded unanimously,

RESOLVED, to authorize Mr. Edwin L. Pirote, Project Evaluation Officer, Bureau Of Local Government Finance (BLGF), As One Of The Signatories For The Checks Issued By The Municipality Of Tigbauan In All Banks Instrumentalities: With The Philippine National Bank (PNB), Land Bank Of The Philippines (LBP) And Other Banking Institutions During His Term As OIC, Office Of The Municipal Treasurer, LGU-Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to the Municipal Mayor, Municipal Treasurer and the Managers of the depository banks of the LGU-Tigbauan, Iloilo, for their proper information and appropriate action.
