**Resolution No. 2005-092**

RESOLUTION REQUESTING THE MUNICIPAL MAYOR THROUGH THE HUMAN RESOURCE MANAGEMENT OFFICER THAT SANGGUNIANG BAYAN MEMBERS, PERSONNEL AND STAFF SHALL NOT BE ALLOWED TO GO ON FORCED LEAVE ANYMORE, FOR THE REMAINING WORKING DAYS OF THE YEAR 2005 AND HENCE, THEY SHALL NO LONGER BE DEDUCTED ANY UNUSED FORCED VACATION LEAVE FROM THE TOTAL ACCUMULATED VACATION LEAVE.

WHEREAS, Rule XVI of the Omnibus Rules Implementing Book V, of E.O. No. 292, Sec. 25 provides that All officials and employees with 10 days or more vacation leave credits shall be required to go on vacation leave whether continuous or intermittent for a minimum of five (5) working days annually under the following conditions: x x x (b) The mandatory annual five-day vacation leave shall be forfeited if not taken during the year. However, in cases where the scheduled leave has been cancelled in the exigency of service, the head of agency, the scheduled leave not enjoyed shall no longer be deducted from the total accumulated vacation leave;

WHEREAS, the Office of the Sangguniang Bayan is burdened with workloads and paper works during the year end;

WHEREAS, the Sangguniang Bayan Members, Personnel and Staff have so many pending Committee Reports such as the 2006 Annual Budget deliberation, Comprehensive Land Use Plan and other Municipal Reports and related documents to work on before the year end;

WHEREAS, it is imperative in the exigency of service, the the Sangguniang Bayan Members, Personnel and Staff shall not be allowed to go on forced leave anymore, for the remaining working days of the year 2005 and hence, they shall no longer be deducted any unused forced vacation leave from the total accumulated vacation leave;

NOW, THEREFORE, upon motion of Hon. Suzette T. Alquisada, Chairman, Committee on Government, Public Ethics, Accountability and Civil Service and duly seconded unanimously,

RESOLVED, to request the Municipal Mayor Through The Human Resource Management Officer That Sangguniang Bayan Members, Personnel And Staff Shall Not Be Allowed To Go On Forced Leave Anymore, For The Remaining Working Days Of The Year 2005 And Hence, They Shall No Longer Be Deducted Any Unused Forced Vacation Leave From The Total Accumulated Vacation Leave,

RESOLVED FURTHER, to furnish copies of this resolution to the Office of the Municipal Mayor, and to Mrs. Luz C. Tronco, HRMO IV and all concerned.
