RESOLUTION AMENDING RULE VII, SECTION I (b) OF THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO

WHEREAS, the Internal rules of Procedure of the Sangguniang Bayan was approved on July 14, 004 per Resolution No. 2004-050;

WHEREAS, Rule VII, Section I (b) of the SB Internal rules of Procedures states: "The regular session shall be held every Wednesday and shall promptly at 2:00 o'clock in the afternoon. Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause, the next working day shall be the regular session day."

WHEREAS, considering the justifications/valid reasons contained in the letter request of Hon. Jose Donel T. Trasporto dated December 02, 2005, the Sangguniang Bayan, on its special session date December 13, 2005, unanimously approved the request by amending Rule VII, Section 1 (b) of the SB Internal rules of Procedure to take effect on Monday, December 19, 2005 quoted as follows: "The regular session shall be held every Monday and shall start promptly at 2:00 o'clock in the afternoon. Provided, however, that that if the day falls on a holiday or the session is prevented by insuperable cause, the next working day shall be the regular session day."
