RESOLUTION FOR AUGMENTATION OF FUND FOR THE PAYMENT OF REPRESENTATION AND TRAVELLING ALLOWANCE OF THE OIC-MUNICIPAL TREASURER, MR. EDWIN L. PIROTE FOR THE PERIOD OCTOBER 21 TO DECEMBER 31, 2005 IN THE AMOUNT OF P18,000.00 (P6,000 X 3 MONTHS) AND PARTIAL PAYMENT OF THE TERMINAL LEAVE PAY OF MRS. LUZ TORRIGUE IN VIEW OF HER RETIREMENT EFFECTIVE DECEMBER 31, 2005 IN THE AMOUNT OF P60,000.00 TO BE TAKEN FROM SALARY SAVINGS OF THE MUNICIPAL ACCOUNTANT FROM JULY 1 TO OCTOBER 31, 2005.

WHEREAS, Mrs. Luz Torrigue, Revenue Collection Clerk, Office of the Treasurer, turned sixty (60) years old last March 7, 2005, has submitted her intention to retire effective December 31, 2005 and consequently the Municipal Mayor has already approved such retirement;

WHEREAS, Mr. Edwin L. Pirote, assumed as OIC Municipal Treasurer effective October 21, 2005 and under pertinent laws, rules and regulations, is entitled to receive Representation and Transportation Allowance for his services rendered to the Municipality;

WHEREAS, the Office of the Municipal Budget Officer has issued a certification that the amount of seventy eight thousand pesos (P78,000.00) is available for augmentation for payment of Representation Allowance and transportation Allowance (RATA) of the OIC Municipal Treasurer and for partial payment of the Terminal Leave Pay of Mrs. Luz Torrigue to be taken from the Salary Savings of the Municipal Accountant from the Salary Savings of the Municipal Accountant from July 1 to October 31, 2005;
