RESOLUTION FOR AUGMENTATION OF FUND FOR THE PAYMENT OF EXTRA CASH GIFT BENEFIT TO OFFICIALS AND EMPLOYEES OF LGU-TIGBAUAN PER LOCAL BUDGET MEMORANDUM NO. 2005-48 DATED DECEMBER 7, 2005 AT SIX THOUSAND PESOS (P6,000.00) EACH TO BE TAKEN FROM PERSONAL SERVICES SAVINGS OF CY 2005 IN THE AMOUNT OF SEVEN HUNDRED THIRTY TWO THOUSAND PESOS (P732,000.00) AND AUGMENTATION OF FUND FOR THE PAYMENT OF: ADDITIONAL BONUS AT P10,000.00 EACH FOR MUNICIPAL OFFICIALS AND EMPLOYEES; FIVE THOUSAND PESOS (P5,000.00) EACH FOR FOUR (4) COA AUDITORS AND OIC-MUNICIPAL TREASURER; TWO THOUSAND PESOS (P2,000.00) EACH FOR FORTY (40) JOB ORDER PERSONNEL; AND ONE THOUSAND (P1,000.00) EACH FOR TEN (10) MEMBERS OF THE BUREAU OF FIRE, TWENTY ONE (21) PNP PERSONNEL AND ONE (1) TRAFFIC AIDE TO BE TAKEN FROM THE SURPLUS/SAVINGS FOR CY 2004 IN THE AMOUNT OF ONE MILLION THREE HUNDRED FIFTY SEVEN THOUSAND PESOS (P1,357,000.00).

WHEREAS, Local Budget Memorandum No. 2005-048 dated December 7, 2005 authorized the grant of extra cash gift/additional benefit to officials and employees of LGUs for fiscal year 2005;

WHEREAS, the amount of Seven Hundred Thirty Two Thousand Pesos (P732, 000.00) as reflected in the certified statement of savings from Personal Services – CY 2005 duly signed by the OIC-Municipal Accountant and OIC-Municipal Treasurer is available for disbursement for the extra cash gifts/benefits to the officials and employees of the Local Government Unit of Tigbauan at Six Thousand Pesos (P6,000.00) each;

WHEREAS, the amount of One Million Three Hundred Fifty Seven Thousand Pesos (P1,357,000.00); is likewise available for disbursement for the additional bonus at P10,000.00 each for municipal officials and employees; P5,000.00 each for four (4) Auditors and OIC-Municipal Treasurer; P2,000.00 each for forty (40) job order personnel; and P1,000.00 each for ten (10) members of the Bureau of Fire, twenty one (21) PNP Personnel and one (1) Traffic Aide to be taken from the Surplus/Savings of CY 2004 in the amount of One Million Three Hundred Fifty Seven Thousand Pesos (P1,357,000.00) per Certified Statement of Savings duly signed by the OIC-Municipal Accountant and the OIC-Municipal Treasurer;

NOW, THEREFORE, on motion of HON. SUZETTE ALQUISADA, Chairman, Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded unanimously,

RESOLVED, to augment Fund For The Payment Of Extra Cash Gift Benefit To Officials And Employees Of LGU-Tigbauan Per Local Budget Memorandum No. 2005-48 Dated December 7, 2005 At Six Thousand Pesos (P6,000.00) Each To Be Taken From Personal Services Savings Of CY 2005 In The Amount Of Seven Hundred Thirty Two Thousand Pesos (P732,000.00) And Augmentation Of Fund For The Payment Of: Additional Bonus At P10,000.00 Each For Municipal Officials And Employees; Five Thousand Pesos (P5,000.00) Each For Four (4) COA Auditors And OIC-Municipal Treasurer; Two Thousand Pesos (P2,000.00) Each For Forty (40) Job Order Personnel; And One Thousand (P1,000.00) Each For Ten (10) Members Of The Bureau Of Fire, Twenty One (21) PNP Personnel And One (1) Traffic Aide To Be Taken From The Surplus/Savings For CY 2004 In The Amount Of One Million Three Hundred Fifty Seven Thousand Pesos (P1,357,000.00).
