RESOLUTION AUGMENTING THE AMOUNT OF FIFTEEN THOUSAND PESOS (P15,000.00) FROM THE BALANCE OF ADVERTISING EXPENSES (P5,000.00) AND REPAIR & MAINTENANCE – OFFICE EQUIPMENT (P10,000.00) TO THE OTHER EXPENSES, OFFICE OF THE SANGGUNIANG BAYAN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Office of the Sangguniang Bayan badly needs office supplies relative to the passage of the Revised Tax Revenue Code and other legislative measures;

WHEREAS, upon verification from the Municipal Budget Office, there is an available balance of Five Thousand Pesos (P5,000.00) from the Advertising Expenses and Ten Thousand Pesos (P10,000.00) from the Repair & Maintenance – Office Equipment or a total of Fifteen Thousand Pesos (P15,000.00) of the SB budget;

WHEREAS, the said amount is necessary to augment the Other Expenses, Office of the Sangguniang Bayan;
