Resolution No. 2005-102

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. MYRNA M. TORRES TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL DAIRY AUTHORITY, THE DEPARTMENT OF EDUCATION, DIVISION OF ILOILO AND THE ILOILO FEDERATION OF DAIRY COOPERATIVES FOR THE SCHOOL FEEDING PROGRAM OF CORDOVA ELEMENTARY SCHOOL, CORDOVA NORTE, TIGBAUAN, ILOILO.

WHEREAS, the Government of the Republic of the Philippines thru the Department of Agriculture forged an agreement with the Government of the United States of America for the supply of Agriculture Commodities, particularly 2,000 metric tons of Non-fat Dry Milk (NFDM), under Section 416 (b) of the US Agricultural Act of 1949;

WHEREAS, the Department of Agriculture – National Dairy Authority, through the NDA-PMD, was tasked to oversee the implementation of the Project which covers the following components, namely: monetization, barter, milk feeding and development of dairy zones;

WHEREAS, 60 percent or 1,192 metric tons of the donated commodities was monetized to fund the requirements for the expansion of the dairy program through the establishment of three (3) new dairy production units in Iloilo and Negros Occidental in Visayas and Zamboanga del Norte in Mindanao;

WHEREAS, the remaining 808 metric tons 40 percent had been bartered by the NDA-PMD to participating dairy federations under the Dairy Confederation of the Philippine (DAIRYCon) in exchange for a corresponding number of 180-200 ml pouches of milk that will feed about 76,344 children in schools and community-based milk feeding programs;

WHEREAS, the Iloilo Federation of Dairy Cooperatives (I FEDCO) is one of the participating dairy federations in the barter, component;

WHEREAS, the LGU has signified its intent and willingness to participate and support this milk feeding program for the implementation in selected barangays of this municipality;

WHEREAS, the DepEd, through its network of schools, has been implementing school-based nutrition programs including milk feeding programs under various sponsorships, has signified willingness to implement the school-based milk feeding project in pre-selected areas;

WHEREAS, the implementation of the milk feeding program shall be supervised by the Inter-Agency Milk Feeding Committee (IMFC), wherein the DepEd is a member;

WHEREAS, for and in consideration of the foregoing premises, their mutual consent hereinafter set forth, the parties agreed to undertake the program;

NOW, THEREFORE, on motion of HON. ROEL T. JARINA, Chairman, Committee on Education and duly seconded by Hon. Alfonsito Estoce,

RESOLVED, to authorize the Municipal Mayor, Hon. Myrna M. Torres To Enter Into A Memorandum Of Agreement (MOA) With The National Dairy Authority, The Department Of Education, Division Of Iloilo And The Iloilo Federation Of Dairy Cooperatives For The School Feeding Program Of Cordova Elementary School, Cordova Norte, Tigbauan, Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Myrna M. Torres, Municipal Mayor, Tigbauan, Iloilo for her information and guidance.
