ROSELLA TRAVINA-VELEZ, BALIKBAYANS FROM LOS ANGELES, CA, USA, FOR DONATING TO THE MUNICIPALITY OF TIGBAUAN, **THROUGH THIS SANGGUNIANG BAYAN** ONE (1) ELECTRO-CARDIOGRAPH (FOR EKG) MACHINE COSTING SEVENTY (70) HOUSAND PESOS, MORE OR LESS, FOR THE PEOPLE OF TIGBAUAN

WHEREAS, the spouses Mr. Edgardo Velez and Mrs. Rosella Travina-Velez, both natives of Tigbauan, Iloilo personally appeared during our SB Session last January 2, 2006, and pledged to donate one (1) Electro-Cardiograph Machine to the Municipality of Tigbauan;

WHEREAS, this Electro-Cardiograph is an instrument for recording the changes of electrical potential occurring during the heartbeat, used especially in diagnosing abnormalities of heart action, and the tracing made by this instrument is known as electro-cardiograph or EKG;

WHEREAS, this Electro-Cardiograph machine is identified as KENZ Model 108; S.N.-0505-6851 manufactured in Japan by Suzuken Co., Ltdd.;

WHEREAS, this donation is unprecedented, being the first of its kind, to serve the urgent needs of the people of Tigbauan with potential heart ailments, who could not othersie afford the highly expensive EKG examination in the city or in private hospitals;

WHEREAS, this donation was made possible through the efforts of the Members of this Sangguniang Bayan (Batch 2004-2007), under the inspired leadership of HON. ROEL T. JARINA, M.D., our Acting Vice Mayor and Presiding Officer;

WHEREAS, we acknowledge with deep gratitude this philanthropic gesture of the spouses Mr. Edgardo Velez and Mrs. Rosella Trivia-Veles, whose donation demonstrates the highest magnanimity of mind and nobility of feeling for the people of their native birth-our beloved Tigbauan;
